



We celebrate the vitality of UUSJ on its Tenth Anniversary year.

The words "challenge" and "social justice" are inexorably linked. This statement is not negative, but rather refers to 'challenges' overcome and 'challenges' to be solved. It is not surprising that this is descriptive of UUSJ.

UUSJ's name and work became more visible this year, in no small part due to our public recognition of the successes of those who take those challenges head-on. The seven awards bestowed at the UUSJ/OpenDoor Benefit Gala showcased the work we do and introduced the many dedicated people who accomplished this work. The proceeds from the Benefit Gala created the UUSJ Collaborative Fund, a new way for UUSJ to foster the goal of increasing the frequency, visibility and impact of UU collaborative efforts across the region. The UUSJ Collaborative Fund is a grant program designed to promote cooperation to enhance the impact of social justice endeavors among congregations, organizations and individuals. The first two grants supported the Ethical Investing Conference held at All Souls and the Interfaith Youth Core event at the UU Church of Rockville on religious pluralism

UUSJ also benefited by inviting the congregational social justice chairs to our Board teleconferences. Their participation not only assisted with planning for UUSJ cluster meetings but also strengthened their social justice network. And vital in the communication-networking process is UUSJ's semi-monthly E-News, a comprehensive, annotated, collection of social justice events and news that continues to receive praise.

On the advice of our Development Committee we changed the method of computing the monetary contributions expected from each church. The base amount expected from each member congregation is \$4.00 per member of that church. Ten member churches met or exceeded their fair share, three were very close, six contributed half or less, and three were unable to make any financial contribution. Considering the economic situation where for non-profit organizations "flat is the new up," we were able to hold our own this year, but hope to do better next year to better serve our member congregations.


And with respect to member congregations, we are delighted that this year the Washington Ethical Society joined UUSJ, and the UU Church of Reston re-joined.

In addition to the development plan, another key tool, the marketing plan, was designed to work in tandem. Specifically, the marketing plan is based on the clear need to improve UUSJ's visibility and viability among its key stakeholders. Marketing is not just promotion or publicity -- it involves the understanding of and responsiveness to the key wants and needs of its membership, and -- as necessary -- modifying its "offerings" to meet those needs. To that end, social action chairs of the member congregations are being interviewed this summer to better identify ways that UUSJ can serve their needs to strengthen our collective social justice efforts in the region.

We are grateful for the success of this past year, and as we celebrate UUSJ's Tenth Anniversary, we anticipate continued good works and expanding collaboration in the coming year.

Executive Director's Report

UUSJ's year involved, in brief:

- 9/20 Cedar Lane held a benefit concert to help finance our Green Festival booth.
- ♦ 9/27 I led a GLBT workshop at the Virginia Revival at Arlington.
- ♦ 10/4 UUSJ provided a display, closing worship, and resource help for the Green Sanctuary gathering at Arlington.
- ♦ 10/22 Our first Gala Awards Dinner in Bethesda honored outstanding area UU social justice people and raised funds for grants to congregations for doing justice work.
- ◆ 10/25 At the Journey Toward Wholeness event in Philadelphia, UUSJ initiated and led the awarding of a certificate of distinguished service to Paula Cole Jones for her dedicated and superb leading of anti-racism efforts. We involved a member of All Souls, the District Executive, and the UUA Moderator.
- ♦ 11/1 At a Board meeting with keynote and workshops, Pam Sparr of All Souls was our keynote speaker on ethical investing.
- ♦ 11/8-9 UUSJ again provided a UU booth at the Green Festival in the D.C. Convention Center. This is the largest area environmental gathering.
- ♦ 11/8 UUSJ met with the JPD Growth Committee and Valerie Holton (UUA growth campaign head) about, for the first time, including an area justice project as part of a regional campaign. The campaign has been presently down-sized due to the economy.
- ♦ 11/15 UUSJ staff attended the UULM-MD (Legislative Ministry) annual meeting to show support and coordinate efforts.
- ♦ 1/11 We held a cluster conference call with the social actions chairs of Maryland to enhance networking and possible cooperation.
- 2/1 We did the same with the social actions chairs of northern Virginia.
- ◆ 3/14 We held a Virginia cluster meeting at Mt. Vernon with workshops proposed by the congregations. (All programming details are in the document on page 10).
- ♦ 4/4 We did the same for the Maryland congregations in Annapolis.
- 4/25-6 At the JPD annual meeting I did a workshop on environmental justice, participated in a
 panel on social justice work, and attended the day-long social-justice training by Rev. John Gilmore.
- ♦ 4/14 Cindy Snavely, Hal Fuller, and I attended workshops on grant-writing and fund raising.
- ♦ 5/9 With the JPD, All Souls, and Arlington, UUSJ sponsored a major conference on Ethical Investing at All Souls. A video of conference highlights is now on the UUA website, program specifics are on pp. 13-16. I was on the planning team.
- ♦ 5/18 At the invitation of Greater Washington Interfaith Power and Light, Cindy and I testified at the EPA public hearings on the ethics of addressing greenhouse gas emissions.
- ♦ 5/31 At our Board meeting at the Washington Ethical Society with keynote and workshops, the main presentation was by Gary Mummert and Lisa Lincoln on environmental justice.

Meanwhile, we continued our traditional ongoing activities and began some new initiatives:

- Two times a month Cindy put out our E-News about area justice events.
- Cindy and Bill Alsmeyer-Johnson have maintained our website, www.uusj.org, with its many resources on area social justice events and organizations.
- We continued to compile our resource libraries on good justice issue speakers for services or other presentations and on congregational policies regarding social justice and environmental issues.
- We took Rev. John Crestwell's community radio show, "The Barbershop," under our non-profit wing and provided logistical support to the Virginia Revival, Green Sanctuary, D.C. UU Interweave and NoVA LUUP.
- We continued to offer our congregations a discounted Green Buying program with GreenLine in York, PA.
- We have cooperated extensively with John Gilmore as he sets up a District-wide social justice organization. I am on his planning committee, and we are trying to weave our structures together rather than duplicating each other.
- We continue to actively work cooperatively with UULM-MD (Legislative Ministry), UUSC, Journey Toward Wholeness, District Growth Committee, GWIPL (Greater Washington Interfaith Power and Light), CCAN (Chesapeake Climate Action Network), VICPP (VA Interfaith Council on Public Policy), WRRCAT (Wash. Regional Religious Coalition Against Torture), the Maryland Interfaith Legislative Committee (MILC) and others in order to avoid duplicating services and confounding schedules.
- ◆ I continue to speak at congregations to raise money and/or to inform them about UUSJ. This year I went to Cedar Lane, Gettysburg, Mt. Vernon (2X), Arlington, Sugarloaf, Southern Chesapeake, Sterling, Accotink, and First Baltimore (2X).
- ♦ Hal Fuller, with Terrie Barr's assistance, developed and revised a Development Plan to put UUSJ on a stable financial footing. This was a huge and important effort.
- Bob Denniston supplemented this with a much-needed Marketing Plan to address our great need to make ourselves fully and clearly known to area UUs.
- We adjusted to a new governing structure resulting from our previous work on bylaws revision and administrative efficiency. The revisions have in general worked very well.

When the major growth/UUA advertising campaign for this area fizzled along with the economy, and the new idea to have a common social justice project as part of it was indefinitely shelved, we of course lost a great opportunity. But everything is on hold, and so this waits as a possible future opportunity.

Surely there will be some follow up to the ethical investing conference, which was a first step in bringing financial people together with social and environmental activists to find points of common ground. Our region is now a UU national leader in this area.

Surely, too, we need to further the vast interest in environmental justice begun by Van Jones' Ware lecture. Our programming at the JPD annual meeting and our May keynote were steps. More are needed.

Also, the success of our Gala last fall has established honoring and celebrating the superb social justice volunteers working in our congregations as a prime function of UUSJ. We can do even more in this area, but Terrie Barr and Par Karlsen put together a fun and inspiring first step.

And lastly, the financial situation of all non-profits makes this a year when we will have to be even more frugal than normal and pay extra attention to fund-raising.

At the same time, with so much happening in Washington in areas of concern to UUs, this is a time ripe with possibility for our mission. We need the ideas and hands-on help of all of us to be worthy of the time. Please help as fully as you can. Our staff time is very limited.

That's why I am so appreciative of the wonderful volunteers who keep us vibrant. Al Robbert has carried the unsung hero job of Secretary of both the Exec and the Board and is stepping down from the Exec. Besides this service, he has brought us his organizational skills and thoughtful mind. Lois Hybl, she of the many hats, is also stepping down from the Exec after bringing us her wise counsel and hard work. We will miss them both on Exec, but are happy they will remain on our Board.


Pat Karlsen, Helen Rose, and Ed Butterworth are ending their Board terms. We'll miss Helen's outreach to young adults and environmental passion, but wish her every joy with her thriving new son Henry. And Ed single-handedly began our Green Festival booth and has been a constant source of creative outside-the-box ideas and resources. Thank you.

Pat Karlsen's indomitable spirits, passion for racial justice, laughter, and good counsel have graced us as Co-Chair these past four years. Terrie Barr is an exceptional replacement, with her many talents and graceful good humor, but Pat is peerless. She has kept us all on the journey toward wholeness, no matter what our focus, and she has kept this Executive Director on task many times, let alone constantly heaping tasks on her own shoulders. We will miss her sorely. The good news, hopefully so with all others stepping down, is that we suspect she and they will pick up new tasks close to their hearts and continue to bring honor and joy to Unitarian Universalism. This is an inspiring consolation.

Co-Chair Bob Dennison's keen calmness and organizational savvy have been a great complement to Pat. Plus he has become our unofficial photographer, a badly-needed resource for us. Treasurer John Harris and Bookkeeper Linda Collyer continue in their dedicated competence to keep us fiscally aware and afloat. The Exec has stepped in and taken on new tasks as needed. Our Board has been rising to the challenges of the new Development Plan. And my colleague in all this, Rev. Cindy Snavely, has handled innumerable simultaneous tasks, great and small, with competence, calmness, and creativity. She's a joy to work with and an invaluable organizational memory and wide-ranging resource person.

We can always work on being more efficient and effective in our work, but as long as there are people such as these and you in our company, we will not fail to build within us, even as we work to build it around us, the beloved community. What a journey, and what a people.

Development Plan

Introduction

In July 2008 the UUSJ Board of Directors approved a three year Development Plan (2008-2011) and authorized the UUSJ Executive Committee to take actions as necessary to implement it.

In essence, the approved UUSJ development strategy looks primarily to its member congregations for funding its basic operational activities. Congregational funding consisted of the recommended "fair share" donations needed to meet basic UUSJ operational expenses.

Additional secondary funding sources included fees from affiliated organizations, membership fees and gifts from individual members. fund raising activities, and occasional grants from foundations and similar charitable sources.

The actions approved by the Board included (a) modifying the relevant UUSJ bylaws; (b) developing "fair share" funding levels for each congregation based upon the size of its membership and the UUSJ annual operating budget as approved by the UUSJ Board; and (c) communicating the resulting information to the members of the UUSJ Board.

The Board members agreed to (a) communicate the specifics of the Plan to the professional and lay leadership of their congregation; (b) work with the Congregational leaders to devise ways and means of achieving the Congregation's donation goals; and (c) follow up with congregational leadership to ensure that the funds are delivered to UUSJ in a timely fash-

The results of the first year of operation under the Plan have been mixed. Most member congregations have not yet met the "fair share" donation targets approved by the UUSJ Board, although nine congregations out of 22 have met or exceeded their targets as of May 8. One congregation is close to making its fair share and 4 are half way there.

Some have not even reached the level of dues payments required in previous years.

Some complaints have been heard that congregations were not consulted before the "fair share" donation targets were established.

Some Board members do not want to be involved as fund raisers; others feel uncomfortable being asked to make a sizable personal donation to UUSJ.

For these and other reasons, the Development Plan has been reviewed and revised...

The new Plan has the following changes:

It reaffirms the "fair share" funding concept based on \$4 per capita for each congregation member.

It clarifies roles and responsibilities for congregations and for UUSJ Board members.

It charges the Development Committee to provide Board members with training and skills development needed to carry out their fund raising responsibilities.

Summary

UUSJ development strategy looks primarily to its member congregations for funding basic operational activities. Additional, secondary funding sources include fees from affiliated organizations, dues from individual members, gifts, ad hoc fund raising activities, and occasional grants from foundations, and other charitable sources such as the Combined Federal Campaign. When feasible, individual donations including CFC contributions are attributed to appropriate member Congregational "fair share" goals.

To implement its development strategy UUSJ

- (1) Encourages stable, predictable funding from member organizations, while providing those members with total flexibility in determining how to raise the money.
- (2) Grows the number of UUSJ individual members, as a means of developing support for UUSJ within member congregations.
- (3) Increases the size of individual donations, where feasible.
- (4) Seeks foundation grants and sizable individual gifts for specific activities when justifiable in terms of programmatic content, but rarely to cover the costs of basic operations.

Responsibilities for Fund Raising

Everyone associated with UUSJ is responsible for raising the funds necessary for its operations.

The Board of Directors

• Approves development and fund raising policy and priorities.

Members of the Board of Directors

- Serve as the primary channels of communication between UUSJ and the leadership of their congregations on fund raising issues.
- With the support and assistance of the Development Committee and the UUSJ staff, encourage members and friends of the organizations they represent to generously support UUSJ.
- Contribute financially to UUSJ as generously as their personal circumstances permit.

The Executive Committee

- Recommends fund raising strategies and priorities to the Board.
- Implements ongoing fund raising operations and programs.
- Oversees Staff activities relating to fund raising.
- Encourages Board members to take an active role in fund raising.

The Development Committee

- Evaluates fund raising possibilities and proposes fund raising activities.
- Makes recommendations to the Executive Committee.
- Assists Board members in carrying out their fund raising responsibilities.
- Arranges for Board members to receive the training and skills development needed to carry out their fund raising responsibilities.

The Staff

- Manages the paper-flow relating to fund raising.
- ◆ Communicates funding needs and requirements to Board members and to UUSJ membership.
- Keeps the Executive Committee and the Development Committee informed about fund raising issues as they arise.
- The Executive Director makes direct appeals to potential donors for funds as directed by the Executive Committee.

Basic Approach to Fund Raising

If UUSJ is to prosper, it requires a stable, predictable income source to meet its basic operational expenses. The best and most reliable source is the member organizations that it serves.

- The basic operations of UUSJ (base salaries, office expenses, etc) are met primarily by annual "fair share" donations from each member Congregation based upon size of Congregational membership.
- Member Congregations have total flexibility to determine how to finance their fair share donation (budget line item, plate collection, fund raiser, individual donations, pledges, etc.).
- The UUSJ board member from each represented Congregation has primary responsibility for ensuring that his/her congregation's fair share donation is forthcoming, assisted as needed by the UUSJ Development Committee and UUSJ staff.
- A strong Marketing Plan is an essential component of a successful Development Strategy. If a member Congregation is unaware of services UUSJ provides, UUSJ has little hope of generating adequate financial support.
- Associate memberships are available to organizations other than Congregations. Affiliated organizations pay an annual membership fee set by the Board.
- Individual memberships in UUSJ are encouraged, partially as a fund-raising mechanism, but also as a means of generating support for UUSJ within each congregation.
- The annual dues for individual membership will be set by the Executive Committee at a level sufficiently low as to encourage broad participation.
- UUSJ programs (as opposed to basic operational expenses) will be financed by the following means:
 - User fees (e.g. registration to attend a conference or workshop), and free will offerings collected at events sponsored by UUSJ.
 - Special event fund-raisers including those co-sponsored with other organizations).
 - Grants from foundations or charitable organizations to carry out specific program objectives with measurable outcomes.

Board Member Responsibilities for Fund Raising

As with almost all not for profit organizations, members of the UUSJ Board of Directors are responsible for the financial health of the organization. This is a moral obligation as well as a legal, fiduciary responsibility.

A willingness to ensure that the organizations that they represent on the Board meet their financial commitments to UUSJ, and a willingness to raise funds on behalf of UUSJ are essential elements of Board members' job descriptions.

Member Responsibilities for Meeting Financial Commitments

Member Congregations and affiliated organizations are expected to make good faith efforts to meet their financial obligations to UUSJ in a timely manner. Quarterly payment of donations will greatly facilitate UUSJ meeting its financial obligations. To assist in this effort, payment reminders will be rendered on a quarterly basis.

The material that follows does not require approval of the Board of Directors. It is provided for informational purposes, so that the Board members understand the implementation steps that will be taken, subject to approval of the Development Plan by the Board.

Actions Needed During Remainder of 2009 Recommendation (1): Obtain Board approval of the revised Development Plan for FY2010-2012

- Target Date for Completion: May 30, 2009
- Lead Action: UUSJ Co-chairs (Bob and Pat)
- Other Participants: Executive Committee, Development Committee Members

Recommendation (2): Continue following-up on collecting FY 2008-2009 "fair share" donations from member congregations.

- Target date for completion: June 30, 2009
- Lead: Development Committee Co-chairs.
- Other Participants: UUSJ Board Members.

Recommendation (3): Follow-up on soliciting and collecting FY 2008-2009 donations from individual members and supporters.

- Target Date for Completion: June 30, 2009
- UUSJ Board members

Recommendation (4): Follow-up regarding membership renewals from individual members and affiliated organizations. This was done in May 2009.

- Target date for completion: October 30, 2009
- Lead: UUSJ staff
- Other Participants: UUSJ Board Members.

Recommendation (5): Arrange professional fund-raising orientation and training for UUSJ Board members to equip them with the skills and confidence necessary for carrying out their fund raising responsibilities – to include familiarity with the UUSJ Marketing Plan.

- Target Date for Completion: September 2009
- Lead: Development Committee Co-Chairs
- Other Participants: Board Members; Staff

Recommendation (6): Conduct a fund raising event during the autumn of 2009.

- Target Date for Completion: 2009
- Lead Action: Development Committee Co-Chairs
- Other Participants: Development Committee Members Staff (Terry and Cyn). Board Members

Recommendation (7): Apply for foundation grants or sizable private donation in support of specific project or projects.

- Target Date for Completion: October 2009
- Lead Action: Development Committee Co-Chairs
- Other Participants: Staff (Terry and Cyn), Development Committee Members, Executive Committee Members

Actions Required: (to be determined by Lead) Status: Action not yet started.

Recommendation (8): Increase the number of individual members and/or donors. Target is to achieve a 10 percent growth per annum for the next four years (2009-2012).

How #1: The UUSJ Executive Committee should take the following steps:

Review and if necessary adjust the current basic individual membership of \$30 per year. Establish a graduated level of rewards and benefits to accompany individual membership. For example:

- \$50 entitles the member to the newsletter and other announcements of UUSJ events.
- \$100 donation entitles the donor to attend UUSJ Board meetings and to speak from the floor on issues of interest.
- \$250 donation entitles the donor to attend UUSJ workshops and events at half cost.
- \$500 donation entitles the donor to attend all UUSJ workshops and events at no cost.
- \$1,000 donation includes a second "free admission" to all UUSJ workshops and events.
- \$2,500 donation entitles the donor to a "member at large" voting seat on the UUSJ Board of Directors.

How: #2 Board members take on responsibility for increasing the number of individual UUSJ memberships in their congregation. Targets are set by congregation based on size.

- Board members will use their own judgment in determining what will work best in their congregation to encourage individual memberships at the various levels in their congregation.
- One approach would be to approach previous donors to UUSJ and other leading social activists on an individual basis.
- Another approach would be for board members to form a small nucleus of "Friends of UUSJ" within each congregation to assist in fund raising activities and recruiting new donors.
- UUSJ Development Committee will provide support and assistance as needed, including talking points and instructions.



Marketing Plan

Preamble:

This marketing plan for UUSJ is based on the clear need to increase the organization's visibility and viability among its key stakeholders. It is intended to be complementary to the recently-approved UUSJ development plan. Together, these plans when implemented can help:

- Assure the long term survival of UUSJ
- ◆ Contribute to the realization of its <u>vision</u> A vibrant and united regional community of Unitarian Universalists working for social justice
- ◆ Accomplish its <u>mission</u> to provide leadership and coordination for effective social action that reflects Unitarian Universalist principles in the region
- Realize its goals to --
 - --advance the social justice work of UU congregations, organizations, and individuals

--increase the frequency, impact, and visibility of UU collaborative social justice efforts in the region

Marketing is not just promotion or publicity – it involves understanding target audiences' wants and needs, and as necessary, modifying the organization's "offerings" to meet those needs. Thus, seeking out and listening to stakeholders (stockholders) is an essential element of a marketing plan, followed by communicating accurately and appropriately back to them so they know we are listening and recognizing their needs. Over time this will allow UUSJ to evolve and refresh our unique value proposition – that is – what is UUSJ offering that no one else has?

The plan is based on a key overarching concept – a belief that social justice work is essentially relational. It is concerned with developing and strengthening partnerships in the broader communities in which we live to advance the common good and to maintain focus on anti-racism, anti-oppression, multiculturalism and environmental justice. And while newer technologies provide improved opportunities for social networking among interested individuals and groups, a key challenge remains how to tell the story about UUSJ accomplishments and capabilities in human terms. The fact that UUSJ does good work – sadly enough – doesn't equate to people caring or taking action. Wherever possible, this story should convey the value of social action on the well-being of individuals and the contribution of UUSJ in advancing the common cause of social justice.

Goal:

To advance understanding of, support for, and participation in UUSJ so that it might pursue its vision and mission with renewed and sustained capacities. (This should be understood to include encouragement for contributions of time, talent, and treasure, including opportunities for leadership recruitment and development.)

Target audiences:

Three key target audiences are the focus of this plan:

- UUSJ trustees and members
- social justice champions (AKA social actionistas) among the member congregations
- congregational leadership among the member congregations
- leadership of other social-justice oriented groups in the region, including foundations and other potential sources of support

While other audiences may be prioritized in the future, these four audiences should be considered "low-hanging fruit" for the near term (the next year).

Strategies:


- Engage UUSJ leadership and trustees in vigorous outreach to member congregations and social justice champions to promote UUSJ and to probe the shared congregational needs that UUSJ could address.
- Provide new and improved tools to make the case for UUSJ.
- Seek outreach opportunities with key regional social justice groups to develop relationships and seek mutually-beneficial collaborations.
- Appoint a PR/marketing committee to organize and facilitate the work, monitor progress, and report quarterly to the board on priorities and new opportunities.

Tactics:

An array of tactics should be employed to ensure that we reach our target audiences with messages that promote the UUSJ mission and priorities. In no particular order:

- 1. Meet face-to-face with the social action leadership of each member congregation within the next two years to increase understanding of UUSJ, to probe the priorities and needs of congregational social actionistas, and to identify promising candidates for UUSJ leadership roles.
- 2. Develop an "elevator speech" and create key talking points to ensure we can comfortably convey UUSJ vision and mission, along with key accomplishments and capabilities.
- 3. Periodically refresh and upgrade the current list of UUSJ accomplishments and provide a downloadable version on the website and for display in various settings, such as display tables, bulletin board postings, SAC tables, relevant regional conferences, etc.
- 4. To help tell the story, add visuals such as photographs of UUSJ-supported efforts to the website, biweekly e-news, and for use in displays, postings, and the like.
- 5. Upgrade the UUSJ brochure and make it available in quantities and/or in downloadable form for use in various settings.
- 6. Promote the availability of Rev. Terry and Rev. Cyn to visit member congregations and deliver themed sermons, with direct relevance to the topical SJ issues of the congregations, and to promote share-the-plate collections for social justice causes (i.e. UUSJ).

- 7. Ensure that the websites of all congregations include links to the UUSJ website and vice versa.
- 8. Develop stories that convey the contribution of UUSJ to regional social justice, for dissemination through the website, e-news, congregational newsletters, and outlets in regional publications, including organizational media and public media. (Good example results of annual Social Justice recognition awards for various media outlets.)
- 9. Enlist expertise of financial leadership from select congregations to provide consultation and/or a peer-led briefing on successful yet painless approaches to support UUSJ financially and other social justice causes without harm to their financial well-being (e.g. the Fairfax experience where 1/3 of each collection is earmarked for social justice).
- 10. Seek to conduct or co-sponsor a regional workshop on environmental justice or socially-responsible investing.
- 11. Pursue opportunities such as Green Fest to promote UUSJ and its value in supporting green action and environmental justice through member congregations and UUA.
- 12. Conduct outreach to social-justice related groups such as LGBT groups, CCAN, WRRCAT, Ministry for Earth and Green Sanctuary, Open Door, VOICE, and others who share our core values
- 13. Follow up with individuals who participated in events such as the "Inspired Faith, Effective Action" to promote individual memberships and leadership development.
- 14. Offer to list social-justice related events on website and in newsletter to congregations and other groups, consistent with policy guidelines. Consider adding a feature to the website to list needs for volunteers or "wish lists" for UUSJ-related functions.
- 15. Develop and promote social justice speaker's bureau.
- 16. Seek high-profile role in JPD Spring conference.
- 17. Develop and disseminate a brief announcement on UUSJ's participation in the Combined Federal Campaign for trustees to place in congregational newsletters and the like.
- 18. Conduct annual UUSJ Awards Gala and use proceeds to support new UUSJ Collaborative SJ Fund.
- 19. As part of regular UUSJ board meetings, twice per year conduct ½ day program on a social justice theme and showcase area SJ "best practices" that are developing innovative approaches. (Could link to the new UUSJ Collaborative SJ fund.)




Congregational Giving Report

On the advice of our Development Committee UUSJ changed the method of computing the monies expected from each church. The base, a charge of \$4.50 per member of any church, times the number of members in the specific church determined the money expected from that church. Ten churches met or exceeded their fair share. Three were very close to their fare share. Six contributed ½ or less of their fare share. Three churches did not make any contribution. Our final bank balance was \$15, 500. Considering the economic storms in our nation this year, we were able we held our own.


UUSJ Green Policy

Unitarian Universalists for Social Justice (UUSJ) is a 501(c)3 non-profit social justice education and enabling agency. UUSJ recognizes and places the highest of priorities on its obligation to responsible stewardship of earth and it beings. To this end, UUSJ seeks to assure environmental justice to beneficiaries of UUSJ social action and all others who are impacted by the quality of the living environment. UUSJ is a leader in relating UU environmental justice vision to the secular and greater faith communities. To this end, UUSJ commits to making the execution of social justice a greener process.

UUSJ works across multiple Unitarian Universalists (UU) congregations in partnership with other faith and secular organizations. UUSJ establishes environmental justice awareness and presence that supports the greater range of environmental justice activity of member congregations, UU Ministry for Earth (UUMFE), Joseph Priestly District (JPD), UU Association (UUA), and our formal non-UU partners approved by the UUSJ Executive Board.

In setting an example of appropriate environmental behavior, UUSJ will conduct its business affairs and meetings with due consideration to mitigating adverse impact on the environment. In the acquisition of goods, services, and facilities access, UUSJ will optimize the use of recycled material, assure recycling of waste, minimize the transport of people and materials, and advocate the use of green computers and network infrastructures. UUSJ commits to being a learning organization ways to improve its environmental performance as humankind gains greater knowledge and insights to the world's environmental problems and solutions.

UUSJ seeks to find opportunities to help educate UUs about life styles that lessen environmental impacts associated with domiciles, transportation, diet, social and cultural practices, business and work place choices, congregation affairs, community education, and practice means to effect environmental improvement and justice at the individual, congregation, multi-congregational, and interfaith levels.



Maryland Interfaith Legislative Committee (MILC) Report

UUSJ is a member of the Maryland Interfaith Legislative Committee (MILC). This organization seeks to influence decisions of the Maryland General Assembly in the field of social justice, especially support for families, low income and disadvantaged people, and environmental concerns. In the recently completed 2009 session, MILC helped pass the following legislation:

<u>Domestic Violence, Protective Orders: Surrender of Firearms</u> (HB296/SB267) Requires that those subject to a final protective order must surrender any firearms and refrain from possessing any firearm for the duration of the protective order.

<u>Termination of Electric and Gas Service during Temperature Extremes (HB 453/SB1057)</u> Prohibits public service companies from terminating service to residential customers for non-payment when the high temperature is lower than 32 degrees or higher than 95 degrees.

<u>Eligibility, for Unemployment Insurance for Part Time Work.</u> (HB 310/SB 270) Provides (under specified circumstances) for unemployment insurance for those able to work only part time.

Modification of Electric Universal Service Program (HB 736/SB 703) Expands the program for providing assistance with electric bills, clarifies the scope of weatherization assistance.

<u>Training Welfare-to-Work Participants for Employment in Green Jobs.</u> (HB 268/SB 992) Requires that a program be developed and implemented to hire Family Investment Program recipients and others, with special emphasis in training for jobs in energy efficiency and renewable energy industries and construction.

<u>Identification Cards for Released Inmates (HB 215/SB 186)</u> Requires that an identification card meeting certain requirements be issued to inmates as they are released from prison

<u>Greenhouse Gas Emissions Reduction</u> (HB315/SB 278). Sets a statewide goal of reducing greenhouse gas emissions by 25% below 2006 levels by 2020; Develop and implement specified programs to achieve this goal.

<u>Preschool Education for All (184/SB234)</u> requires development of a business plan to extend preschool education to all children, and identify a funding source.
