UUA President Rev. Peter Morales, Salvador Reza, leader of an immigrant rights group in Phoenix, and four others stood trial Friday, July 29, 2011 for their actions of non-violent civil disobedience protesting the Arizona law known as SB 1070 one year ago.

"When I think of the people who are suffering and dying as a result of our broken immigration system, I know I did the right thing a year ago. And I know all of us who stand on the side of love will have to make that stand again and again." wrote Rev. Morales. He made a commitment; he took a risk.

UUSJ received a UUA "Challenge Grant" of \$7,500 for the fiscal year 2011-12. The grant will help support the first of a two year project to "inspire, engage and equip UU congregations in the National Capital Area" in transforming "concern for immigrants into action for justice and advocacy on behalf of immigrants".

UUSJ made a commitment and is taking a risk. UUSJ must come up with an equal amount in matching funds *that do not come out of our operating budget* to fund the immigration project. We will be drawing part of the matching funds from unused portions of last year's Collaborative Grant program, partially from this year's Social Justice Gala event, and partially from contributions from individuals.

At Mt. Vernon on Feb. 26, ninety people attended a plenary with UU ministers and others describing why and how their congregations were involved with immigration issues. Workshops and state-specific gatherings followed. We worked with allies: Immigrants First, Virginia Coalition of Latino Organizations, CASA of MD, Capital Area Immigrants Rights Coalition.

Maryland passed the Dream Act, allowing undocumented Maryland high school graduates to pay in-state college tuition. Opponents have petitioned for it to be on the 2012 ballot and hope voters will overturn the law. "...all of us who stand on the side of love will have to make that stand again and again."

Immigration was one of UUSJ's priorities this past year; the others are the environment and GLBTQ rights. We had good attendance at our programs on these two important priorities.

UUSJ ended the year with a slight surplus because Rev Terry Ellen voluntarily worked fewer hours and both he and Rev Cynthia Snavely held down costs and Combined Federal Campaign revenues were up. Ten of our congregations met or exceeded their fair share of \$4.50 per member. Thank you; you are our most important sources of moral and financial support.

Executive Director's Report

This past year UUSJ continued its practice of determining the three most engaged social justice issues in our congregations and developing programming around these issues. The basic structure of our year was thus formed by our major events focused on environmental, immigration, and GLBTQ issues, together with our annual Awards Banquet, Green Fest booth, and JPD annual meeting workshop(s):



On Sunday, Oct. 17, at our Awards Banquet, 65 people feasted together and honored inspiring area UU leaders in a number of social justice areas. There is no finer rea-

son to come together and no finer group of people to be with. It was a grand event, with Pat Karlsen and Terrie Barr deserving organizing kudos. The funds raised go to our various grants for cooperative social justice projects initiated by congregations.

Our Oct. 23-4 booth and panel presentation at Green Fest was a singular success due to the engaging booth designed by Caryl Henry Alexander (Davies) and our outstanding panel of Jewish, Christian, and Muslim leaders addressing the need for their faith traditions to respond to the environmental crisis.

At All Souls on Nov. 13, 39 people heard a presentation on the exciting possibility of offshore wind power for the region, followed by workshops and breakout state and district groups. Paula Cole Jones was our keynote speaker on environmental justice, with presentations from CCAN, GWIPL, and 1Sky.

At Mt. Vernon on Feb. 26, ninety people attended a plenary with UU ministers and others describing why and how their congregations were involved with immigration issues. Workshops and state-specific gatherings followed. As with our other events, we brought in a number of allies and experts to lead discussion.

At the April 9 JPD annual gathering, UUSJ presented a workshop to thirty people on the immigration study resolution, with Revs. Cynthia Snavely (Bowie), Carlton Elliot Smith (Arlington) and Scott Sammler-Michael (Accotink) presenting resources and congregation action examples. One of the candidates for the UUA Board attended.

45 people registered for our GLBTQ event May 7 at Cedar Lane concentrating on issues of or youth and young adults. Our afternoon venue was an experiment in attracting younger people, and special thanks go to Cindy Snavely for her leadership in pulling this all together.

In addition to these major events, we:

Applied for and received a UUA grant for a major initiative focused on immigration issues in this region. Bob Denniston, with the able assistance of Hal Fuller and the rest of the Executive Committee, deserves high raise for pulling this application together.

Continued our efforts to facilitate contact between social action committee/council chairs with an engaging networking conference call Feb. 13 led by Bob Denniston.

Facilitated the D.C. Gay Pride day by bringing in a number of congregations to help Arlington finance and assemble a parade contingent and booth.

Presented in services at River Road, Accotink (Terry), and Davies (Terrie Barr).

Continued our cooperation with the District's Journey Toward Wholeness and Growth committees as well as the Unitarian Universalist Legislative Ministry of Maryland and the former Northern Virginia Legislative UU Priorities Network.

Sent out our bi-weekly E-News to 390 people.

Updated and refined our financial plan of fair-share congregational contributions, including our 122 individual contributors. Hal Fuller (Fairfax) deserves special thanks for his dedicated work in this effort.

This all is in addition to the continual incoming requests by congregations for all sorts of information and the continual updating of contact lists essential to our being able to work together. I am so fortunate to work with so competent, dedicated, and cheerful a colleague as Rev. Cynthia Snavely, who manages to juggle multiple balls, holds institutional memory, and

and uses her wide range of social justice contacts to enrich our programs. UUSJ has always been most lucky to have her.

Our Executive Committee works hard to make the many decisions required for such an active year. Our Co-Chairs, Treasurer John Harris, Secretary Mike McCord, and members Hal Fuller and Pat Karlsen put in much work implementing Board decisions, shaping programming, and fundraising.

Of course almost everything depends on the hard work and wisdom of our Co-Chairs Bob Denniston (Arlington) and Terrie Barr (Rockville). They are a terrific combination of vision, dedication, hard work, and extraordinary competence in a range of areas. Their leadership has been the crux of our success. Bob's term is up, and he is a great loss to us. His organizational skills, clear thinking on mission and feasibility, as well as his outstanding involvement in social social justice issues, often with his wife Lavona on their many trips to Guatemala and New Orleans, among other things, has been an inspiration and help of huge effect. The only thing that softens his leaving is the knowledge that we will surely be working with him in new capacity.

So, too, John Harris's (Columbia) term on our Exec, and as Treasurer, is up. John, besides his work keeping us fiscally solvent, has been a constant voice for moving UUSJ always toward being a more anti-racist and multicultural venture. In discussions too numerous to mention, he has been a constant voice of reason, hope, and civility. He did major work in upping his congregation's fiscal support for UUSJ. We will miss him, but know we will be working with him anew. And we are again most lucky to have Linda Collyer continue as our Bookkeeper. She is a gift to us from the gods.



Also new are Al Carlson becoming official as Reston's board member. Moya Atkinson is Arlington's new board member with Ric Blacksten as alternate. Also, the Washington Ethical Society has a new alternate, Patti Absher.

And, finally, it is you people who carry on this work in our congregations, weaving together from our many independent congregational ventures a collaborative effort of greater impact, vibrancy, mutual support, and collective wisdom than would otherwise be happening in this region. God knows the times call for way more than we can possible do together, but all we do to enhance our mutual work is toward a cause that inspires us, challenges us, no doubt drives us occasionally crazy, but echoes with all the heartfelt resonance of that ancient call to do justice, and to love mercy, and to walk humbly with our God. May we be worthy of that high calling, that task, and these times.



2010-2011 Annual Meeting Minutes

Unitarian Universalists for Social Justice

Board Meeting May 7, 2011, 11:00 am Cedar Lane UU, Bethesda MD

UUSJ Members Present: Co-Chair Bob Denniston, Co-Chair Terrie Barr, Executive Director Rev. Terry Ellen, Administrator Rev. Cyn Snavely, Treasurer John Harris, Secretary Mike McCord, Pat Karlsen (Executive Committee at-large), Hal Fuller (Executive Committee atlarge), Charlie Culbertson (Towson), Ron Brandt (Mt. Vernon), Nancy Boardman (Paint Branch), Nancy Sorden (Washington Ethical Society), Al Carlson (Reston), and Brian Hobbs (filling in for Ed Kringer, Accotink).

Observers present: Patti Absher of WES, Tillman Neuner (taking notes for Kay Scott from Cedar Lane), and Ken Shilling (Goodloe).

The meeting convened at 11:05 am. A quorum was present.

Chalice Lighting

Rev. Terry Ellen gave the opening words and lit the chalice.

Check-ins

Reston just expanded their building and has a new minister Erin Gingrich and celebrated their 40th anniversary.

Mt. Vernon is getting solar power to take main building off the grid, funded up front by Shenandoah Sustainable Power. They will then pay back the costs through the rates. He was asked to submit info on this for the e-news.

Fairfax added 95 members in the last 12 months, heading from 800 to 1000 members.

Columbia opened up a cold weather shelter this past winter.

Cedar Lane has anti-racism/intolerance group CLARITY

Accotink passed a statement of conscience on immigration. They were asked to submit it for the e-news.

WES is supporting anti-torture, about to vote on joining a Washington interfaith group.

Arlington disbanded their social action council, seeking to be more inclusive on deciding on their priorities, and hired Rev. Carlton Elliott Smith for 2 years,

Bob Denniston and Ron Brandt led discussion of how Mt. Vernon elects task forces to vet social justice priorities. It was urged that we discuss how congregations decide their social justice priorities at our September meeting.

Executive Director's Report

Cyn circulated Terry Ellen's executive director's report by email prior to the meeting on May 5. Terry did not repeat any of that, in the interest of time, but corrected the number attending the banquet last October (it was 63 not 33). His report, as amended, is included below as attachment #1 to these minutes.

Ron asked how well we keep current our list of congregation SJ leaders. Cyn does it but depends on input from our congregations. Cyn would also love to get each congregation's annual report as well and post them.

In July Terrie will have more info on small/mid-size congregations as part of our awards.

Minutes from February meeting

The minutes from the February 26, 2011 board meeting, which were emailed to the Board by Cyn on May 4 and May 5, were accepted as corrected after Bob Denniston noted the maximum grant amount referenced therein should be \$20,000 rather than \$8,800.

Treasurer's Report

John reported that he was unable to send the report around by email prior to meeting. A copy of his report is included below as attachment #2.

In addition to his written report we got big check from the Combined Federal Campaign (CFC) that will be on top of the 84% of income mentioned in his report. He has not received the Union Sunday check either. John noted that 66% of our pledges have come in.

Terrie thanked Terry and others for recalculating our administrative costs to make us more competitive in the CFC. Cyn stated that we hope to become part of United Way as well.

Terrie recognized Accotink for tripling their fair share last year, and still doubling it this year. She said we have 8 fair share congregations this year, down from 10 last year, but she still hopes we can get to 10.

Bob and Hal submitted a 28-page \$19,800 grant application on immigration issue, on time, to the UUA to fund year one of a 2-year program to inspire, engage and equip our congregations to engage and act on immigration. He expects to hear back on/after June.

A \$400 youth grant to Paint Branch was returned to UUSJ as they were unable use it.

Budget for 2011/2012

John stated we are still hoping to get 100% but now planning on/budgeting for only 80% of congregational fair share amounts (not 80% of what they did last year), but we are not telling congregations that and we should not lower our expectations to that.

The fair share is \$4.50 per member, which is unchanged since we started the fair share.

Terrie noted that River Road now allows members to pledge direct to designated social justice organizations and we aren't on that list after many years. We don't know what we will get from them, they used to be a very big donor. A new designated River Road pledge organization is UULM MD (which we helped create).

Terrie stated that we would love to do better and pay Cyn and Terry more, they have cut back, and we agreed the minutes should reflect their sacrifices on behalf of UUSJ.

Bob noted that All Souls is voting tomorrow on a new social justice minister and Terrie said they hope to appoint a representative to UUSJ in June and get back with us.

The budget was approved by a unanimous vote.

Nominations and Vote

Bob presented the slate recommended by the Executive Committee: Terrie Barr for a one year extension as co-chair, Hal Fuller for a 2-year term as the other co-chair to allow us to stagger the MD and VA co-chairs, for Treasurer Mike McCord and Nancy Sorden for Secretary, both for 2-year terms. Hal was previously co-chair, one of the first co-chairs. Terrie is entering the last year of three 3-year terms as Rockville representative, so after this year she will have to leave UUSJ.

The nominations were approved by a unanimous vote.

Recognition of Outgoing Board Members

Three outgoing board members were recognized with orchids and certificates

Ron Brandt has kept Mt. Vernon at its fair share, worked Greater Washington Growth, the Virginia Interfaith Center, and many other efforts over many years.

Treasurer **John Harris**, who is retiring in 146 days (but who's counting?) and will start traveling more and stepping back from leadership roles.

Co-Chair **Bob Denniston**, who has served 4 years as co-chair. Bob will not continue as either co-chair or as the Arlington representative, though he may continue coming to UUSJ meetings. Like John, Bob may also retire from his job this year. His wife Lavona was also a former co-chair of UUSJ.

Fund Our Communities/Bring the War Dollars Home

Nancy Boardman requested UUSJ consider endorsing the "Fund Our Communities/Bring the War Dollars Home" effort. Concerns were raised about having our regional organization support a county organization, and the need to be consistent on this point was noted. Terrie and Hal will attempt to draft something for the Executive Committee.

Nancy clarified that they are asking for endorsement of their goals, not financial support, and that it has endorsers beyond Montgomery County, but none in Virginia so far. Mike noted we had similar debate a year ago about NovaLUUP and ultimately decided not to post a link to them on our website. Jean Athey asked us to sponsor this. We will ask her to make a presentation to the board if the Executive Committee makes a policy decision prior to the September board meeting that would make it possible for the Board to act on and approve the policy and to vote on her request.

Closing/Extinguishing the Chalice

Rev. Cyn Snavely provided closing words and extinguished the chalice. The meeting adjourned at 12:39 pm

LGBTQ Program

The board meeting was followed by a UUSJ program entitled "Supporting LGBTQ Youth: Community Needs and Resources", also held at Cedar Lane, from 1 to 5 pm on May 7. Speakers included representatives from UUA's LGBTQ Ministries, Children's Hospital, parents LGBTQ youth, and speakers on the special concern of LGBTQ persons of color.


Treasurer's Report

Despite the difficult economic circumstances UUSJ is holding its own. The Unitarian Universalists for Social Justice continues to be in good financial health. As with the past two years, the first half of the year was very rocky. By year end we were in great shape with \$26,713.88 in UUSJ's bank accounts, compared to \$18,360.38 for 2009-2010. Our year to date (July 1, 2010 to April 30, 2011) income (actual to Budget) was up by \$675.20 or 101.87%, expenses were under budget by \$2,285.38 or 93.66% less them budgeted.

The Executive Board is working hard to keep UUSJ in good financial health for the 2011-2012 fiscal year and beyond. With the development plan and the 2011-2012 budget with only minor increases, UUSJ will remain a strong force for Social Justice in the Baltimore, Washington and Northern Virginia areas.

UUSJ thanks the Congregations and Individuals for their financial support. And we look forward to continual working with you, in our joint Social Justice pursuits.



2009-2012 Development Plan Summary

Summary

UUSJ development strategy looks primarily to its member congregations for funding basic operational activities. When feasible, individual donations including dues from individual members, and Combined Federal Campaign (CFC) contributions are attributed to appropriate member Congregational "fair share" goals. Other funding sources include fees from affiliated organizations, for example the Chesapeake UU Ministers Association, (CUUMA), ad hoc fund raising activities, undesignated gifts and occasional grants from foundations.

What is a "Fair Share" Goal?

Each year the Board of Directors approves a recommended level of giving for each member congregation of UUSJ. This amount is based on congregational membership as reported to the UUA. The per capita amount takes into account several factors including economic circumstances and the budgetary needs of UUSJ. In recent years the "fair share" amount has been set at \$4.50 for each member of the congregation. Congregations are encouraged to meet or exceed this goal.

Member Congregations have total flexibility to determine how to finance their fair share donation (budget line item, plate collection, fund raiser, individual donations, pledges, etc.). Member Congregations and affiliated organizations are expected to make good faith efforts to meet their financial obligations to UUSJ in a timely manner. Quarterly payment of donations will greatly facilitate UUSJ meeting its financial obligations. To assist in this effort, payment reminders will be rendered on a quarterly basis.

Responsibilities for Fund Raising

Everyone associated with UUSJ is responsible for raising the funds necessary for its operations. The Board of Directors approves development and fund raising policies and priorities. Members of the Board of Directors serve as the primary channels of communication with their congregations on fund raising issues and, with assistance from the UUSJ staff and Development Committee, encourage their congregation, members and friends of the organizations they represent to generously support UUSJ. Duties of other UUSJ elements are set forth in the full Development Plan.


