Since we don't have an Executive Director to prepare a report, I'm writing a Board Chair Report covering the period since October 4, 2014. The report summarizes many of the things we are doing together and my activities, meetings and calls in the name of UUSJ.

This is not a typical report. I started with a mention of program, events and activities that seem to be of more major importance, and things that the Board might benefit from by knowing more detail. Since we are missing many committee and task group reports, I started filling in a few blanks.

Then... I went to my calendar to remind me of what I was doing and when, and I started a journal of activities. I decided that would be helpful for various purposes like the annual report.

The Core Group has discussed the need to get a better handle on the amount of time the chair and a new executive director might need to spend on UUSJ work. I thought my calendar/journal would give us a good picture. So skim through, or read it all and I hope you come away with a better understanding about what many of the volunteers and your elected officers and core group team are up to. And you might see an area where you might participate to help move UUSJ towards its vision.

# **General Thoughts:**

(See separate reports from the Program and Nominating Committee and the Immigration Task Group for more details)

These past months I've made a special effort to do "relational work" as they say in community organizing, working to meet with as many people as I can to talk about all phases of UUSJ life from our new vision and asking and learning from people with experience about what's reasonable and doable, and where to go for information. I highly recommend it. Get together with at least one person a month to talk about growing our UU voices and working together to advance our UU principles. Not just social justice folks but people who have expertise to help us grow our vision.

Based on my own experience and talking to a lot of people, it is a fact that volunteers in most organizations these days are not able to consistently carry out the work that is needed to maintain, none the less grow, the 21st Century non-profit organization. We need to hire more staff soon before we all burn out.

The Board instructed us at our June 22 retreat to focus on governance and continue to pursue our programming and advocacy efforts. That has been harder to do than anticipated. Major problems remain that we have too much work, for too few volunteers and staff. The Core Group believes we need to take the leap, even though our infrastructure and governance structure isn't yet where we would like them to be, and hire someone or two and develop our advocacy abilities and opportunities for engagement by our volunteers and donors.

We need to better reach out to our various community members. Our communications are a critical part of how we get our message out to large numbers of people. We need improved "messaging" to reach various target audiences. We have not yet used the power of social media to reach people. We moved in the right direction by seeking professional assistance to help us prepare a tailored communications plan and calendar. Now we have to implement it.

Mass means of communications like emails is most efficient, but it is least effective. Personal relationships, one to one meetings, are least efficient but most effective. Both are necessary. We all need to do our part in reaching out. Invite people to lunch, to have coffee or take a walk and talk about their and your passions and ways to make a positive difference in the world. We

believe there is more power working together than there is alone. That goes for individuals and congregations.

The full support of the Board is needed to make a difference - support in addition to moral support, that includes time, talent and treasure - at least two hours per month for a start, financial support, and sharing of your talents/and or finding the talent we need.

We have a grant of \$5,000 from the UU Fund, with a \$5,000 matching option (details are in the section below). The Core Group members have been talking about the next steps; chicken and the egg, hire someone or raise the matching funds. We need a plan and we want to expand beyond the Core Group to get more people involved in the decision-making and work that will need to be done over the next few months. I would like to jump start the Development Committee and find some of you who would like to work on this task for a couple of months.

There are many areas in which you can become engaged. If no one has reached out to you, please reach out to us to let us know where you'd like to participate, whether it's a short term task, tapping your expertise from time to time, or joining an ongoing committee or issue group. It's an exciting but challenging time for UUSJ. We've moved beyond just approving the strategic plan. We've looked at our infrastructure and are having the deep discussions necessary to take UUSJ to the next organizational level to carry out its vision and mission.

### Lavona's UUSJ Work Journal

I am an active member of the Program Committee. This past year I have focused much of my time and attention to working creating a relationship with the UU Association and UU Service Committee staff to collaborate on joint programs and events. This has come with some frustrations, since the UUA has been going through structural and programmatic change for nearly a year. But I believe it is a mutually beneficial relationship. We were able to be of assistance, which gave us recognition, in working very closely with Susan Leslie, Congregational Advocacy and Witness Program staff, in Boston.

I was very disappointed that two events fell through, but we all gotten to know each other much better by working together! First, I'd been talking with Susan Leslie from the UUA since July about jointly holding a <u>reception or luncheon with area ministers</u> but it couldn't get off the ground. In early December, Pam Sparr, UUSC, joined in to support the idea of hosting a luncheon in conjunction with a Congregational Hill briefing that UUSC was hosting on February 26, sponsored by Representative Conyers office. Coordination, agreement on the purpose of the program, and extreme difficulty finding a room at the Capitol, caused us to postpone the event. John Gubbings, did a heroic job trying to find space working with two Congressional offices but to no avail, but then found a church across the street from the Capitol at the last minute. We'll keep it and several other venues we found in mind for future Hill events.

The second event was the repeat program from November, 2014 that we wanted to offer north of the beltway, "Inspired Faith, Effective Action." This program had an advocacy component that we are eager to share with area congregations. Due to limited staff availability and difficulty finding a date, we cancelled the program for this year. Rev. David Carl Olson, First UU Church of Baltimore, is willing to host the program at the Baltimore church.

## **Summary of UUSJ Programs, Events and Collaborative Programs:**

October 4, 2014: first program of the year "Beyond the Partisan Divide," with Revs. Scott and Anya Sammler-Michael, at the UU Church of Accotink. About 30 people were present.

December 6, 2014: briefing on the new Congregational Study Action Issue, Escalating Inequality, held at the Washington Ethical Society, about 32 people were present.

January 10, 2015: meeting of the regional UUSJ environmental group. Over 35 participated.

February 26, 2015: UU Service Committee (UUSC) Capitol Hill Briefing, sponsored by Rep. Conyers office was a new experience for us. The briefing was on water affordability and availability. I worked closely with Pam Sparr, UU Service Committee (UUSC), to provide on-site support and to recruit ministers to "witness" and learn about the growing water problems in the Despite bad weather, five UUSJ members attended and provide onsite support to UUSC including taking photographs. We were able to turn out five UU ministers, with collars and stoles, to witness at the briefing; a sixth minister was unable to attend due to a family emergency.

March 14, 2015: "How to Make Your Climate Efforts Count." I worked closely with Pam Sparr to create a tailored program for our area UUs to launch the new Commit2Respond program and to conduct a strategy session with our area UUs. Pam became ill the week of our program and had to cancel her attendance but the program went forward with UUSJ volunteers. In spite of another day of bad weather, about 23 people participated. The location was downtown on Thomas Circle. We opted to pay \$250 for a conference room at a church across the street from where the Spring Lobby Weekend (SLW - for details see below) was taking place allowing us to take advantage of the kind invitation by Jose Aguto from Friends Committee on National Legislation (FCNL) to attend the opening and hear the program keynote speaker at SLW. About seven UU young adults attended the SLW. One of the attendees from North Carolina, took us up on our invitation to join our morning meeting. Participating at the last minute and joining our UUSJ team of volunteer presenters was Kaeley Pruitt-Hamm, Advocacy Corp Coordinator from FCNL.

**Co-sponsors:** We have signed on to be sponsors of the UU **Commit2Respond** climate justice program, and the **Grandparent Climate Action Day** <a href="http://www.eldersclimateaction.org/gcad2">http://www.eldersclimateaction.org/gcad2</a>. The support a national agenda to reduce carbon dioxide emissions and reduce use of fossil fuels. The Executive Committee believed this is a good intergenerational event to promote among our congregations and members.

**Grant to UUSJ**: UUSJ was awarded a grant in early December from the UU Fund for \$5,000 with an option for a \$5,000 matching grant. The purpose of the grant is to develop an implementation plan based on our strategic plan and jumpstart our advocacy agenda. We asked for \$20,000. Currently we plan to raise at least \$2,500 through the UU crowd funding site faithify.org and an additional \$2,500. We now are working on a plan to coordinate our funding appeals.

**Special Contribution to UUSJ:** We received \$1,000 from a foundation in Maryland that was supporting the New York Climate Action March, for our work with Interfaith Power & Light for our efforts in organizing efforts to mobilize the interfaith community to participate in the march.

**Communications**: Following Board OK at our November 22 Board meeting we hired a consultant, Monique Hanis, to work with the Communications Committee and Core Group to develop and write a Communications Plan. The plan was completed in January. The Communications Committee has met several times since January and has been working on

launching a new commentary blog for ministers and lay leaders. A letter was sent to many of the area ministers in March to invite them to write a commentary. The response to the letter to date has not been good. You can find the commentaries on the home page of our website. Also, a new website will be launched this summer. We will send out a survey regarding eNews. Currently we are sending out one regular eNews and a mid-month mini eNews each month.

**Relationship Building with UU Organizations:** As part of our relationship building and trying to move forward some program ideas, John Gubbings, Treasurer, Jim Alcauskas, BRUU, and I met on December 8 with UUA staff Susan Leslie (Boston UUA), Taquiena Boston, and Jessica Halperin from the UUA Washington office, and Pam Sparr, from the UU Service Committee.

On January 5, 2015 several of us, including Ed Kringer, Dean Wanderer, David Strauss, Cyn and I had a conference call, which included members of the UULM-VA Board, to learn from and explore common social justice concerns with Rev. David Pyle, JPD District Executive and Program Manager for Social Justice for the Central East Regional Group (CERG). Rev. Pyle said he and his staff are available to conduct training. Neither CERG nor JPD have a legislative agenda. They are available to support congregational and organizational efforts to but do not take a position on any social justice issue.

## **Immigration Steering Committee:** See separate committee report.

On December 9, the Immigration Steering Committee (Dean Wanderer, Accotink, David Strauss, Rockville and I) met with Edgar Aranda-Yanoc, Virginia Coalition of Latino Organizations (VACOLAO) to build relationships and identify mutual areas of interest. This was a follow up to a meeting I had with him nearly nine months earlier. A few months later, Edgar asked us to support offering DAPA clinics following the President's Executive Order. We had a volunteer willing to represent UUSJ at weekly planning meetings but within a few weeks the effort was put on hold due to the court case coming out of Texas. Note: There isn't a functioning Immigration Task Group at this time. We do have a immigration listserv.

Within the last two months we've launched our advocacy work on the Hill. We've made two Hill "relational" visits and attended a Senate briefing on deportation representing UUSJ. John Gubbings and I attended and we talked with Church Service United staff and made a connection with a minister from Phoenix, with whom we'll follow up.

**Raising Money:** We tried something new. The Core Group launched an end-of-the-year fund appeal following an appeal to Board members at the November 22, 2014 Board meeting. Nearly \$2,400 was raised during November - December.

**New Task Group:** Relaunching our Bylaws Task Force and Duties and Responsibilities Task Group that was formed following our governance retreat. The new combined group will be called the Governance Task Force. It will encompass work on general governance issues, development of board duties and responsibilities, bylaws review and changes (for September consideration), develop a covenant, consider a Board member engagement plan (recommended by Michela Perrone, our governance consultant) and create a policy and procedure manual.

Monthly **Program Committee** conference calls have been discussed and agreed to, but we've not yet found a standing day/time for our call. When we have a program coming up, we increase the number of calls as needed. We always debrief within about two weeks following a program.

Bi-weekly (every two weeks) **Immigration Steering Committee** conference calls and periodic face-to-face lunch meetings. Next lunch meeting is scheduled for April 10.

Ongoing tasks include customizing **donor Thank You letters** to congregations and individual donors (print, sign and send Thank You letters about two times per month). I include a yellow sticky or other handwritten note on the letter, and often modify the letter for people I know personally. Most recent rewrite of the template for Thank You letters was in late March.

**UUSJ meetings:** I am a "member," for now, of all committees and task groups. Because I am also filling the role of the Executive Director, it's hard to withdraw from being the convener of meetings. My intent is to help jumpstart committees and task groups and then fade into the background.

**Other meetings:** When I attend social justice meetings in the community focused on UUSJ priority issues and organizing efforts, I attend as chair of UUSJ. If appropriate, I bring our brochures and I use my UUSJ business card when networking with participants and sponsors. Many conferences and events mentioned below are listed because I went in my role as UUSJ chair, and I registered with UUSJ as my affiliation and it appeared on my name badge.
