Recent Accomplishments

Sent out letter to a select group of clergy, who are generally clergy at member congregations, introducing our concept of a commentary blog. Said commentary would pertain to UUSJ primary issues . (See http://uusj.net/wp/category/commentary/ for examples.) No response so we will have to explore a different approach. Communications Plan: the committee met with a consultant, Monique Hannis, who used

input from the committee members to draft a communications plan. Her plan is attached.

Current Projects

- 1. Revamping email blast template.
- 2. Creating and emailing out a questionnaire regarding our eNews, format, and frequency.
- 3. Revising the website.

Future Plans

Implementing the communications plan.

Requests/Needs

More volunteers to help with media posting and updates.

Specific tasks for media volunteers are:

- Regularly consult the communications plan and media posting calendar.
- Research UU efforts pertaining to a major item on the media calendar. For example, research current and past work done specifically by local UU's around and for Earth Day.
- Using the information researched help develop Facebook and Twitter media postings.
- Meet regularly with Communications Committee, either face to face or on the phone.

Volunteers to help with website redesign. No technical skill required as we will discuss color schemes, what we want on the main page, what we want on interior pages. Design discussion will generally be done using a large white board, post-it notes.

A volunteer with experience in producing short videos.

Explanations

Social Media

Social media, Facebook, Twitter, LinkedIn, Instagram, are all tools that can drive the very connected younger generation to our website and can be used to motivate them to contribute and to join us. There should be regular postings to each of these platforms in a

way that best suits the platform. For Twitter, it was suggested that we not use all 140 characters, that we use short succinct sentences with links to postings on either Facebook or our website, and that we use lots of pictures.

Approach: our communications consultant advised us to pursue a three step approach. Step one is to concentrate on volume, that is putting out a lot of social media content. Step two is to begin focusing on engaging our social media followers by homing in on their interests. Step three is to begin measuring the effectiveness of our social media postings.

The other suggestion made by our consultant is to use as much graphics as possible. We now have access to a great number of graphic items, templates with which to create posts.

Videos

Our communications consultant, as well as many others, have spoken of the effectiveness of short videos in engaging people, especially the younger generation. These videos can be posted to our Youtube Channel, to Facebook, Twitter, and to our website.

Website Design

Research on effective, engaging websites, as well as conversations with consultants, make it clear what such a site should look like, what features it should have. Main Page, the purpose of this page (front page) is to engage non-members, prospective members, not necessarily current members. It is part of our advertising strategy. Interior pages, such as "About Us", can serve to answer questions a prospective member may have as well provide information for current members.

Websites must also be responsive. That is they must automatically reformat themselves to look good on whatever device they are being viewed on. A recent article noted that many students with limited access to "regular computers" (i.e. desktops, laptops) generally can only access the internet via a smart phone. So it is vital that our website look great on a smart phone screen, that it have all the relevant information a phone user might want and that it be easily accessible.

A website design meeting focuses not on technical implementation but on layout and features. Such sessions use flip charts or whiteboard, color markers, post-it notes, to lay out the design.

Immigration Task Force: March 27, 2015

The Immigration Steering Committee includes Dean Wanderer, chair, David Strauss, and Lavona Grow.

We are pleased to report that the Steering Committee of the Immigration Task Force launched its new Hill initiative in winter 2015. With Congress firmly in the hands of anti-immigrant forces it is clear that there will not be a comprehensive immigration reform bill considered such as there was in S. 744, the bi-partisan bill passed by the Senate in June 2013. Following the 2014 elections both chambers of Congress appear to be much too conservative to expect positive legislation.

In December 2014 and January 2015 UUSJ leaders consulted with leading progressive groups such as the American Immigration Lawyers Association, Farmworker Justice, and the UUA to map out ways to promote a just and equitable immigration reform program. The strategy until the 2016 elections is to try to prevent negative legislation from passing while educating as many members of Congress as possible on the plight of undocumented and other immigrants living in our communities. Of course, our commitment is largely driven by the Statement of Conscience on Immigration adopted by the UUA General Assembly of 2013 and the activities of our member congregations.

Pursuant to our strategy, we recently conducted visits to the offices of Senator Tim Kaine (D-VA) and Representative Chris Van Hollen (D-MD). We also participated in a briefing for Senate offices on March 20. Both Sen. Kaine and Rep. Van Hollen's staff were enthusiastic about our involvement in promoting positive immigration reform, and they pledged to keep us informed about any legislation filed by Congressional members hostile to such reform.

The briefing on March 20 was sponsored by Church World Service and the National Immigration Law Council under the Senate sponsorship of Senate Minority Leader Harry Reid (D-NV). About 25 Congressional offices participated, plus numerous NGOs, including UUSJ. The focus was to encourage the Administration to use its prosecutorial discretion to avoid deportation of undocumented immigrants, with special attention to those in sanctuary at religious institutions, such as the Denver UU congregation.

The UUSJ Immigration Steering Committee believes it is critically important to present a strong presence on the Hill on behalf of our commitment to immigrants and their families. We will continue to meet with Senators and Representatives from the National Capitol Area and beyond to promote the interests of immigration reform and to educate federal elected officials about UUSJ, our mission, and connection to so many active UUs.
